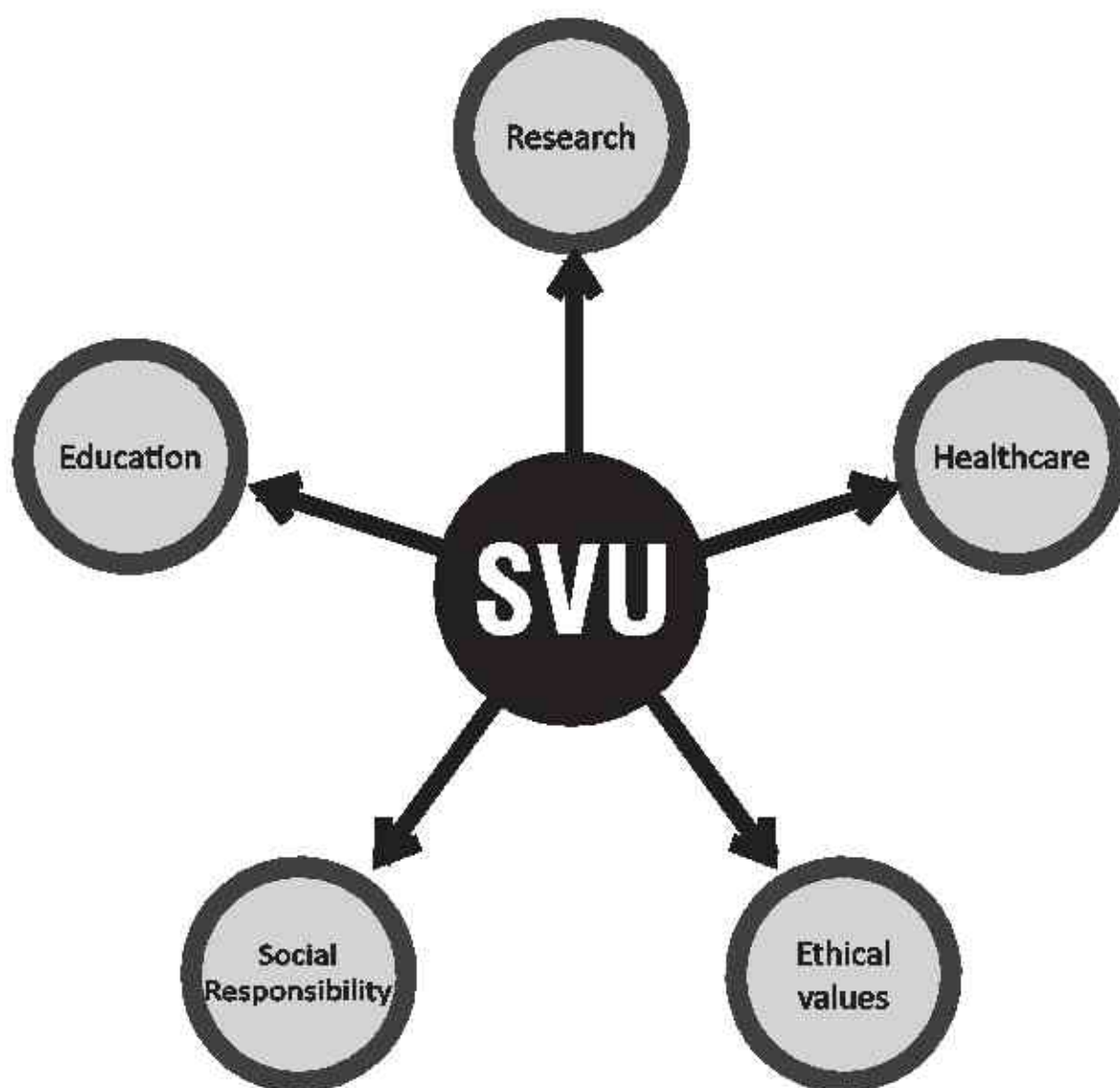

## **Evidence Based Education System**

### **Introduction**

It was being felt since long that the knowledge and skills obtained during the training in healthcare, during undergraduate and post graduate courses are insufficient to carry on lifelong successful healthcare practice and decision making. To make decisions, the practicing professionals even today are largely dependent on obsolete knowledge and expertise derived from unsystematic observations made during his training, which can be as old as his course itself.

Evidence based medicine (EBM) was introduced to do away with this trend in the medical field. It simply means the need for judicious use of current, objective information in making decisions about the care of individual patients. The term was coined to encourage proficiency in judgments by individual clinicians based not only on “experience” but also on experience informed by results acquired in systematic approach.

Incorporation of same principle in all aspects of teaching and learning process to impart the process more perfectly is Evidence Based Education System (EBES) which was adopted by our university with the aim to create individuals skilled in all ways to use evidence to make individual decisions. The adoption of EBES is all the more imperative since the ‘Internet Revolution’ has provided immediate and easy access to new research.

Many may ask why evidence based? The answer lies in it being scientifically sound, is patient focused, incorporates clinical experience, is thorough and comprehensive, stresses on good judgment, use of empirically-verified treatments in the care of patients, incorporation of research results into the process of care, ability to critically appraise research results.

EBES is thus an innovative emerging area needed for promoting knowledge based learning & self-learning. Sumandeep Vidyapeeth adopted it since its inception (2007) to establish an educational system which to overcome the present shortfalls and to be at par with global education system.

### **Objectives:**

- To prepare health care provider of first contact, capable of functioning independently in both urban and rural environment with special attention to diagnosis prevention and treatment

planning of the diseases/health related problems and prevention of same by being abreast to scientifically proven empirical evidence.

- To provide education that allows hands-on-experience both in hospital as well as in community setting with systematic evidence based approach, educational experience that emphasizes health rather than only disease with outcome-based education as a goal.
- To inculcate the technique of reasoning, ability to understand the evidence, the nature and hierarchy of the evidence, critically choose the best evidence and apply it in clinical practice.
- To facilitate a learning experience that will provide the skills to develop, implement and disseminate an evidence-based approach for effective health care practice.
- To provide the doctor/dentist/health care provider who will believe in the value of life-long learning and value the evidence in making clinical decisions over opinion. EBES can lead to better skill and knowledge which ultimately will benefit society.

5. Preparation of disease specific treatment protocols in all subjects with best available evidence and its application on reference population, its modification as per need after feedback analysis and research.

**Outcome till now since inception of the program - Impact of EBES****On Students**

- Students have become less fearful of facts, figures and statistics, and are well oriented in research methodology. They can comprehend and analyze latest research articles. As a consequence they are conscientious and ethical, evidence- based, research –oriented and patient –centric.



- They have inculcated scientific and ethical practices, based on solid verified principles rather than individualistic, arbitrary doctrines. It has led to formulation of management protocols for diseases prevalent in the region. This has accrued maximum benefit to the patients in form of standard and rational treatment.

### **On Society**

- EBES is making teachers and professionals accountable. As a consequence – Treatment has become ethical & cost effective and addresses issues of drug and investigations misuse. Above all, it has transmitted a spirit of working on evidence and endeavoring to generate evidence and making this search a life-long process. It will in the long term form database from community centric hypothesis based research, which might at some stage help in formulation of State and National health policies. This will bring maximum benefit to the community, society and the nation at large.

2. Regular teaching of evidence based subject at Undergraduate & Post graduate level - sensitization of students to evidence based concept.
3. Wider acceptance from faculty and staff.
4. Formulation of Evidence based subject module.

## Major Activities

### 1. Support to School Students:

As part of social responsibility, the university regularly provides support to needy **School children's** especially from Government Primary schools situated in the nearby areas of University, by providing them Free School uniform, School bag, Shoes and books; as per the need of the student.

2. Financial support was provided to **466 Jain students** from low income group (less than Rs.1.80 lakhs/PA) from the adjoining areas, for educational purpose, in the form of tuition fees, school uniform, books etc. amounting **Rs. 41.67 lakhs**.

3. The Financial support was provided to **Children's of Sumandeep Vidyapeeth Employees**, under '**Gyanvardhak Scholarshipscheme**' of Sumandeep Vidyapeeth. The total support amounted to **Rs. 2.04 lakhs**.

### 4. Serving community through health camps and community center's:

i. The University had organized **multi-specialty Medical & Dental checkup and Diagnostic & Therapeutic camps** in semi urban and rural areas of Gujarat and Madhya Pradesh, for the marginalized and weaker sections of the society. During this Academic year more than 65 such camps were organized and it benefited around 22,619 needy. The total expenditure incurred was about Rs. 57.38 lakhs. Around 2296 patients, who required further treatment, were referred to our Medical and Dental Hospital.

ii. Various Health related programs are regularly conducted in collaboration with Department of Health and Family welfare, Government of Gujarat. The Government has recognized our Dhiraj Hospital as a Regional Monitoring and Training unit. The OPD services rendered to the nearing Tribal areas are mainly focused related to Obstetrics & Gynecology, Pediatrics, General Medicine, Dermatology, and Ophthalmic. The patients who needed comprehensive treatment, were referred to our Medical and Dental Hospital, where the treatment provided was total free of cost. In the current academic year till date **1500** persons were benefitted from our services.

iii. The total of 77 Oral Health awareness, Dental and Oral Cancer Screening camps were organized during the year. The total of 7240 patients of different age group and background were benefitted. The patients who needed comprehensive treatment, were referred to our Dental Hospital. A special Denture camp was organized for Geriatric Population in the rural area of Savli Taluka. The totals of 30 Senior citizens were benefitted.

iv. The Teaching Faculties and Students of Physiotherapy in collaboration with an NGO- 'Friend's Society' regularly attend Differently abled Children and provide treatment and rehabilitation services on weekly basis and the total of 120 patients are benefitted till date. The Physiotherapy services are also rendered to the ofPHC Waghodia, wherein 47 patients were benefitted till date in this academic year.

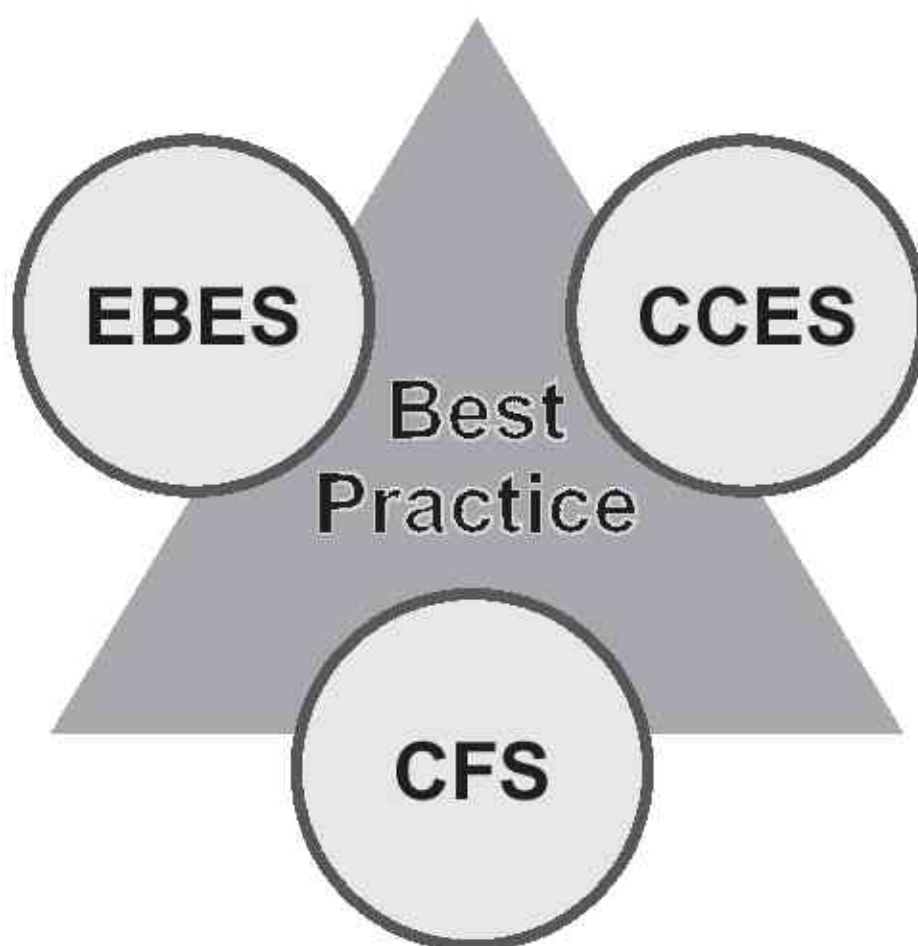
