For UG (Undergraduate Students)

- For undergraduate students, regular EBP theory classes are being taken as per syllabus on a weekly basis (represented on timetables of each year). Along with the theory classes practical demonstration (on laptops) are also being taken and recorded (EBP Bank).
- After theory class, regular assignments (records) are also being given to students, corrected and returned.
