### ADMISSION NOTIFICATION-PH.D. PROGRAMS - 2019

Applications from eligible candidates are invited for admissions to Ph.D. Program (Full time / In service/ Part time) in Faculty of Medicine, Dental, Pharmacy, Physiotherapy, Nursing and Healthcare Management of Sumandeep Vidyapeeth Deemed to be University for the Academic Year 2019-20.

### Eligibility;

- a) Candidates with MD / MS, DM / MCh /PG Diploma/ MSc (Medical) degree from MCI recognized college / Institution are eligible for Ph.D. Programs in Faculty of Medicine.
- b) Candidates with MDS or equivalent Master's degree from DCI recognized college / Institution are eligible for Ph.D. Programs in Faculty of Dental Sciences.
- c) Candidate with PG degree in Physiotherapy (MPT), PG degree in Pharmacy (M Pharm) & Pharma D and PG degree in Management from a college / Institution recognized by IAP / PCI / AICTE / UGC as the case may be are eligible for Ph.D. in Faculty of Allied Sciences.
- d) Candidate with PG degree in Nursing (MSc) from a college / Institution recognized by INC are eligible for Ph.D. Programs in Faculty of Nursing.
- e) Regular employees of Sumandeep Vidyapeeth Deemed to be University are eligible for "Inservice" Ph.D. programs in their respective faculty provided they meet the eligibility criteria mentioned in UGC (Minimum Standards and Procedure for Award of M. Phil / Ph.D. Degrees) Regulations 2016.
- f) Part time candidates from outside the institute must be a full time/regular faculty of Medicine/ Dental /Allied Health Sciences with minimum of 2 years experience at the time of admission and sponsored by the concerned institute / organization. The candidate should be working in an organization which encourages and facilitates research. He/she meets the requisite minimum qualification for admission to Ph. D. program of Sumandeep Vidyapeeth deemed to be University. The candidate must submit a "consent & no objection certificate" from his/her parent organization recognized by concern council. Other terms & conditions remain the same as in Sumandeep Vidyapeeth Ph.D. Regulations for Admission to Ph.D. Program.

### g) for In-Service Ph.D. candidates:

- In case of teaching candidate; he/ she must have minimum one year continuous service in SVDU and for non-teaching candidate; he/ she must have minimum five years continuous service in SVDU.
- Candidates have to submit an application for No Objection Certificate (NOC) through respective HoD and Hol. The final approval shall be given by the University.
- Candidates shall agree to serve the constituent institution / college/department for a minimum period of two years after the award of Ph.D. degree.
- Further the in-service Candidate will execute willingness to deduct Ph.D. fees from his / her pay which will be refunded to the in-service candidate after 24 months from the date of award of the Ph.D. and completion of bond period without any interest.
- The candidate has to pay the fees for the extended period of prescribed duration for the study of degree of Ph.D. as the case may be.
- On discontinuation of service for reasons whatsoever, the Ph.D. registration of such in service candidates shall stand cancelled. However he/she may re-registrar for Ph.D. program as full time/part time candidate subject to submission of NOC from the new employer (recognized by concerned council) and payment of requisite fees as external part time candidate.
- > He/ she should not have any adverse remarks as far as discipline is concerned.
- h) Candidate must have scored minimum of 55% marks for General Category and 45% of marks for those belonging to SC/ST/OBC (non-creamy layer)/differently-abled category in the entrance examination conducted by the Universities. Provided further that, if in spite of the above relaxation, the seats allotted for SC/ST/OBC(Non Creamy layer)/Differently-Abled categories remain unfilled, the concerned Universities shall launch a Special Admission

#### Cancellation of admission and Refund of Fees:

If a student chooses to withdraw from the Ph.D. programme of study in which he/she is enrolled, the SVDU shall follow the following five-tier system for the refund of fees\* remitted by the student.

Percentage of Refund of fees*	Point of time when notice of withdrawal of admission is received in the Higher Educational Institution (HEI)
100%	15 days or more before the formally-notified last date of admission. (before 01-07-2019)
90%	Less than 15 days before the formally-notified last date of admission. (02-07-2019 to 14-07-2019)
80%	15 days or less after the formally –notified last date of admission. (15-07-2019 to 31-07-2019)
50%	30 days or less, but more than 15 days, after formally-notified last date of admission. (01-08-2019 to 15-08-2019)
00%	More than 30 days after formally-notified last date of admission.  (on or after 16-08-2019)

#### Note:

- In case of (1) in the table above, the HEI concerned shall deduct an amount not more than 5% of the fees paid by the student, subject to a maximum of Rs. 5,000/- as processing charges from the refundable amount.
- In case of (5) in the table above, the payment of the fees for balance years by redeeming unconditional bank guarantee / cheques in favor of Sumandeep Vidyapeeth for the payable amount if the student leaves the course after the 30 days of formally-notified last date of admission or during middle of course.

 Fees shall be refunded by HEIs to an eligible student within fifteen days from the date of receiving a written application from him/her in this regard.
