
SUMMARY OF ACTIVITIES DONE UNDER FDC (2018-19)


Incentives given during academic year 2018-19:

During this academic year, that is, 1stAugust 2018 to 31stJuly 2019, there were total 57 faculties of various constituent institutes were benefited under the policy of incentive for paper/poster presentation and attending FDP. Out of 57 faculties, 42 faculties were given incentive for paper (poster/oral) presentation 13 faculties were given incentives for attending various faculty development program/training and 02 faculties were given incentive for invited as Speaker at an International Conference outside India. During this academic year FDC, SV has released total 7,05,268/- INR as incentive to various faculties for presenting paper or attending FDP/Training. In the previous academic year, there were 32 faculties from constituent institution and incentive of Rs. 3,78,483/- INR was given to faculties. (Table 2)


Incentives given for Award in Paper/Poster Presentation:






• Academic Events organized during academic year 2018-19 (through FDC):

During 1st August 2017 to 31st July 2018, total 74 applications from all the constituent institutes and University Section of Sumandeep Vidyapeeth for academic events organization were reviewed by FDC, SV. Out of 74 academic events organized, 2 were International level, 19 events were of national level, 16 events organized at state level, 19 events were of university level and 18 events were of institute level. The amount funded by the university in the organization of academic events was Rs. 20, 23,113. In the previous academic year, there were 51 academic events organized after the review by FDC with funding of Rs. 1, 22,500. (Table 4)






Table 6 shows the faculty serving as chairpersons at various academic events. There was 05 international events where the faculty from Sumandeep Vidyapeeth served as










Table 10 shows that the number of publications in conference proceedings from faculties of constituent institution is 34. In the previous academic year, there were 17 publications in conference proceedings
