Hospital Management System is in practice both in Dhiraj Hospital and K M Shah Dental Hospital since 2007. This comprise mainly of Patient records regarding admissions, treatments, discharge etc. 2. Libtech 1.4 is Library management software which has been used since 2009 for acquisition, cataloguing, circulation, administration, reporting and patron records. 3. Sumandeep Vidyapeeth Learning Resource Centre has a Fully automated Library with KOHA library management system. The Online Public Access Catalogue (OPAC) module which provides a simple and clear interface for library users to perform tasks such

as searching and reserving books and suggesting new books. 4. The Institution's Learning Resource Centre (LRC) has developed Institutional Repository System by using Dspace Open source software. Faculty publications, Thesis and Dissertations and other study materials can be uploaded and accessible through link. 5. Inventory Management is used for tracking inventory levels, orders, sales and deliveries. 6. Mess Record helps to create and publishes daily meals calendar, mess billing etc. It generates attendance records for students and assigns them to mess and/or canteen. 7. The Continuous and Cumulative Evaluation System (CCES) is in place for systematic evaluation of each student in both, theory as well as practical / clinical, is carried out through tablet, using software. 8. The Admission Management System is used for all the student admission procedure.
