As Central Government by notification, constituted a Commission, to be known as the National Commission for Homoeopathy, to exercise the powers conferred upon, and to perform the functions assigned to it, under NCH Act 2020. As per section 59 (2) of NCH Act, 2020, following has been stated.

"Notwithstanding the repeal of the Homoeopathy Central Council Act 1973, the educational and medical standards, requirements and other provisions of the Homoeopathy Central Council Act, 1973 and the rules and regulations made there under shall continue to be in force and operate till new standards or requirements are specified under this Act or the rules and regulations made there under: Provided that anything done or any action taken as regards the educational and medical standards and requirements under the enactment under repeal and the rules and regulations made there under shall be deemed to have been done or taken under the corresponding provision of this Act and shall continue in force accordingly unless and until superseded by anything or by any action taken under this

As per provision in the Act Medical Assessment and Rating Board for Homoeopathy has been constituted with the mandate to grant permission to the existing and new medical institution of Homoeopathy. Accordingly, it is to inform you that all the relevant documents submitted by your college were examined by the Medical Assessment

On careful consideration of the report, the Medical Assessment and Rating Board has arrived at the following conclusion:-

That the applicant has set up a Homoeopathic Medical College with the component of staff, infrastructure, equipment and instruments and other facilities where as the College has to take urgent steps to implement Minimum Standard Requirements for the Homoeopathy College and attached Hospital as prescribed by the National Commission for Homoeopathy for obtaining permission for establishment of new College. Following deficiencies

- (i) OPD/IPD register of only 01 month is provided. OPD/IPD register and data of the last 01 year should
- (ii) Herbal Garden is under renovation.
- (iii) Salary bank Statement of hospital staff not provided. The same may be provided for the last one year.

MARBH has conducted inspection of the college on 06.07.2022 & 07.07.2022 and the College is directed to fulfill all deficiencies within a period of 30 days and the Compliance report may be submitted after fulfilling the shortfalls. Considering the infrastructure and other facilities available, Medical Assessment and Rating Board has decided to issue permission to Sumandeep Vidyapeeth Homoeopathic Medical College and Hospital with intake capacity of 100 seats for the academic year 2022-23.

The college has to comply with the full requirements as per Minimum Standard Requirement Regulations, 2013 for conducting UG course. The Board shall verify the compliance well in time and may conduct Online/Physical inspection for verification of compliance as per the Regulations and the recognition of the courses will be issued accordingly.
