This MoU is for establishing the collaboration between SVDU and KSS, especially for Persons with Disabilities (PwD), in the area of Rehabilitation Services, Health Care Services, Joint Research and Innovation Projects / Studies, Joint Programs / Courses, Incubation Centre, Startups, Community / Social Service, Joint Health checkup and Treatment camps, Joint Conferences / Seminars etc. The collaboration between both the parties herein under, is based upon the principles of mutual interest.

Preamble

About SVDU:

Sumandeep Vidyapeeth Deemed to be University was notified through Gazette Notification of Ministry of Human Resource Development (MHRD), Department of Higher Education, Government of India, through vide notification No.F.9-46/2004-U.3 dated17th January 2007, as 'Deemed to be University' under de novo category. The Vidyapeeth was established under Section 3 of the University Grants Commission (UGC) Act, 1956 through vide Notification No. F.No.6-106/2004 (CPP-1) dated 9th March 2007, and vide Notification No. F.6-106(1)/2004 (CPP-I) dated 26th August 2008. The MHRD through its notification no. F.9-46/2004-U.3 16th December 2019, has extended the 'Deemed to be University status' for Sumandeep Vidyapeeth Deemed to be University, from 17th January 2012 onwards. The Institution is accredited by National Assessment and Accreditation Council (NAAC) at 'A++' Grade with CGPA of 3.61 at Four-point scale, and is also conferred with Category - I Deemed to be University status, by University Grants Commission (UGC).

These Hospitals cater to the needs of Local population, especially, from Madhya Pradesh, Rajasthan and Maharashtra, and Tribal Districts of Gujarat. Dhiraj Hospital has a state of art Cancer Diagnostic and Treatment facilities. The Hospital is the major source of Clinical and Academic Research for the Teaching Faculty, Researcher and Students of the Institution. The Clinical Section of the Department undertakes Rehabilitation Services for Persons with Hearing and Speech Language Disability, from more than 20 years at Dhiraj Hospital, SBKSMIRC. The Rehabilitation services in the hospital does not limit to the following: (1) Evaluation and treatment of hearing loss and tinnitus (2) Assessment and Rehabilitation of auditory and balance disorder (3) Provision of hearing aids, assistive and alerting devices (4) Post Cochlear Implant management (5) Evaluation and treatment of speech, language, voice, and swallowing disorders (6) Rehabilitation for Speech Language Pathology.

About KSS

The Kalrav Special School, a Non-governmental organization (NGO), was established in 2008, in Vadodara, Gujarat, India. The objective of the organization is to help Mentally Challenged children and manage their disabilities and lead a better life by facilitating Healthcare facilities. Children from the economically weaker section of the society that had very limited resources for their special needs are preferred.

Kalrav currently supports 40 such children, where in they engage in varied activities which will help develop their motor skills, improve their mental abilities and gives them an opportunity to stand-up in the society with pride. Following are the activities, to name a few – activities of daily living, Academic activities, Vocational activities, Cultural activities, sport & game, Therapeutic Intervention, Rehabilitation & Integration in the society, Guidance & Counseling to parents, Providing Mid-Day Meal & transportation to/from their home to school.

Kalrav takes care of all the expenses to run the school including all such activities listed above & more, without any expected contribution from the parents of the children, as Majority belong to the non-affording class. The expenses are being met from the Contribution by Trustees and good Samaritans of Vadodara.

Scope of the Collaboration

Especially for Persons with Disabilities (PwD), in the focused areas, such as Rehabilitation Services, Health Care Services, Joint Research and Innovation Projects / Studies, Joint Programs / Courses, Incubation Centre, Startups, Community / Social Service, Joint Health checkup and Treatment camps, Joint conferences / seminars etc.

General Areas of Cooperation

This MoU will govern the relationship between the SVDU and KSS regarding Rehabilitation Services to Persons with Disabilities (PwD) of any age.

Both SVDU and KSS shall encourage interactions among Clinicians, Teaching Faculty members, Non-Teaching Staff, Students and Children/Patients through the following arrangements, but not limited to:

- For the management of Persons with Disabilities (PwD), including Mental Retardation, Cerebral Palsy, Audiology and Speech Language disorders, Autism, ADHD, Down's syndrome and other types of Intellectual Disabilities, etc.
- Clinical Screening and Assessment of various Impairments in PwD and normal individuals.
- 3. Medical and Rehabilitation camps to be organized jointly for PwD and normal individuals, if any.
- 4. To jointly participate in the development of an individual education program for school age children.
- 5. To undertake research projects / studies as needed for PwD.
- To undertake or device new aids / equipment's required for Persons with Disabilities (PwD), and to Patent / Copyright the same, either individually or jointly.
- Research, Innovation, Startup etc. shall be undertaken in the campus of Sumandeep Vidyapeeth Deemed to be University, in relation to Persons with Disabilities (PwD).

Confidential Information

SVDU and KSS agree for not disclosing any type of confidential material, knowledge, study results or information. The parties may like to share this with one another but may decide not to disclose it to any third party. In the event if it is required to be shared with a third party, except as an when required by law; then mutual consent in writing must be obtained from the other party, prior to disclosure. This Non-Disclosure Agreement (NDA) creates a confidential relationship between the parties to protect any type of confidential and proprietary information or trade secrets.

Intellectual Property Rights

Ownership of any intellectual property (including but not limited to confidential information, know-how, patents, copyrights, design rights, rights relating to computer software, and any other industrial or intellectual property rights) developed jointly during the course of this MOU shall be vested in both parties to this Memorandum. Both parties shall have the joint right to determine the commercial exploitation and disposition of such intellectual property, and both parties shall make joint applications for the registration of the same. Before any registration or commercialization of any intellectual property takes place, the parties agree to each a separate agreement covering issues such as exploitation rights and revenue sharing.

Any publication regarding such intellectual property shall only be possible with the prior written consent of both parties, such consent shall not to be unreasonably withheld.

Participating Teaching Faculties, Non-Teaching staff and students involved in any activities under this Memorandum must adhere to the law of the country and rules and regulations of the Institution.

Legal Effect

Nothing in this Memorandum shall be construed as creating any legal relationship between the parties. This Memorandum is a statement of intent to foster genuine and mutually beneficial collaboration.

Commencement and Tenure of MOU

The present MoU shall become effective from the date of signing. It shall remain in force for the period of Five (5) years i.e. from 07th July 2022 till 06th July 2027. This MoU will be amended / terminated with mutual consultations and written agreement, as and when needed.

Dispute Resolution

Any dispute or difference arising out of or in connection with the interpretation or implementation of this MoU or out of or in connection with the breach, or alleged breach of this MoU, each Institution shall attempt in the first instance to resolve the conflict amicably by mutual agreement between the two representatives of the organization. Conflicts that cannot be resolved amicably shall be settled by arbitration.

Sumandeep Vidyapeeth Deemed to be University and Shree Parshwa Medical and Education Trust's Kalrav Special School, welcomes the establishment of this Memorandum for cooperation and jointly agrees to the provisions as set out above.
