Memorandum of Understanding

This Memorandum of Understanding (MoU) is signed on **14th July 2023**

Between

Sumandeep Vidyapeeth Deemed to be University

At Post Piparia, Taluka Waghodia, District Vadodara, Gujarat state, India.
(Hereinafter referred to as **SVDU**)

And

Manahshrushthi Charitable Trust

A/11, Shivanjali Society, Opp. State Bank of India, Rajesh Tower Road,
Near Hari Nagar, Gotri Road, Vadodara - 390023. Gujarat State, India.
(Hereinafter referred to as **MCT**)

This MoU is for establishing the collaboration between SVDU and MCT, in the areas of Capacity building and services for Persons with Disabilities (PwD) in the focused areas such as Rehabilitation Services especially in hearing & speech impairment, Senior Citizens, Community promotional activities on health, Community based Rehabilitation, Academic / Educational programs, Research & Innovation Projects, Startups, Research focusing on Community / Social Service, Staff Exchange programs, Research Publications, Collaborative Conferences/ Seminars/ Workshops etc. This collaboration between both the parties herein under is based upon the principles of mutual interest.

1. Preamble:

About SVDU:

Sumandeep Vidyapeeth Deemed to be University was established on 17th January 2007 under section 3 of the University Grants Commission (UGC) Act, 1956, through Gazette notification of Ministry of Human Resource Development (MHRD), Department of Higher Education Government of India, through vide notification No.F.9-46/2004-U.3 dated 17th January 2007, as “**Deemed to be University**” under *de novo category*. It is one of the premier private Institution of higher education mainly focusing on Healthcare education, and is committed to mentor the students in achieving their potential in education, research and employment. The main focus of the Institution is student-centric and student-directed.

The Institution is conferred **Category - I** Deemed to be University status by UGC, and is accredited by National Assessment and Accreditation Council (NAAC) at **A++** Grade with CGPA of **3.61** at Four Point scale in Second cycle. 

Manahshrushti Charitable Trust was established with a spirit of social services in the country of religious harmony and co-operation. It is a non-political, non-profitable- social organization. It was started with a dream and a purpose for the upliftment of Tribal Community in Village: "Manka", Taluka: Kawant, District: Chhotaudepur 15 years ago. The trust undertakes activities such as Vocational training, Health Care, Nutrition, Education, Environment, Consumer awareness, Women awareness, Agriculture training, Sport and Cultural activities, Promotion of Science and Technology, for the SC/ST/OBCs/ Minorities and other weaker sections of the society.

The Trust has a local unit of manufacturing the Unique Quality Candle with high-tech technology. The candles are made by trained tribal women's, and are exported to various countries. The other products which are manufactured are Hair-Oils, Creams, Balms, Detergent, Soap, Liquid Soap, Agarbatti, Dhup, Cakes, Chocolates, Art & Craft Articles, Brooms, Doormats and many more.

The Trust, since last three years, is focusing on the work in the areas of Health and Nutrition, Pregnant Women, Preconception Women and Children's, with an aim to create awareness, educate, free treatment, providing free medicine, free Nutritional Supplementary food kits & guidance. The Trust is involved in distributing Nutritional kits for TB patients, support for health and Menstrual Hygiene Management for Rural Women by distributing Sanitary Napkins etc. in Districts such as Narmada Chhotaudepur and Dahod.

2. Scope of the Collaboration:

The present MoU will be jointly conducted between SVDU and MCT with defined areas. The core objectives comprises of, but not limited to the following:

- A. Will jointly Conduct Research studies in the areas of healthcare and healthcare services.
- B. Will undertake Collaborative research by sharing the research facilities and writing collaborative research projects in the fields of health sciences for Government funding, if any.
- C. Both the parties will undertake Staff exchange programmes in order to gain knowledge in all the areas including Medical Technology.
- D. To jointly organize Local / State / Regional / National / International Conferences, Seminars, workshops etc. to disseminate the relevant knowledge to the participants and stakeholders, significantly in the area of healthcare sciences.
- E. To collaborate for conduction of in-house trainings to the staff on various aspects of healthcare services, mainly focusing on Community promotional activities on health and Community based Rehabilitation.

- F. Will submit Collaborative high end research projects, Community promotional activities on health to various Government / Non - Government funding agencies, at State / National / International level.
- G. Will jointly conduct community based health camps, focusing on sensitization / awareness programs, diagnostic & treatment camps, etc.
- H. Capacity building and services to Persons with Disabilities (PwD), in the focused areas, such as Rehabilitation Services especially in hearing & speech impairment, Children's, Senior Citizens etc.

3. General Areas of Cooperation:

This MOU details the modalities and general conditions regarding collaboration between the two organizations, which shall encourage interactions among the stakeholders of both the parties, through the following arrangements:

- A. To organize and execute the programs desired with mutual consent.
- B. To provide services for Persons with Disabilities (PwD), in the focused areas, such as Rehabilitation Services especially in hearing & speech impairment, Senior Citizens, Socially Marginalized Section of the Society such as women, people with disabilities, the aged, scheduled castes and scheduled tribes etc.
- C. To work on mutually acceptable projects including but not limited to community activities, especially for societal benefit, and assist policy makers in healthcare areas.
- D. Both the parties shall propose research concepts / ideas to any national/international agencies for financial assistance/ development of innovative devices / products / clinical trials and exchange of personnel through deputation as per the rules of the respective institute, as mutually agreed upon;
- E. There will be no restriction on the contents of the research report and on publication of the results of the research study, subject to the condition that no Intellectual Property Rights (IPR) can be secured for any part of the work which will be decided with mutual consent.
- F. If the outcome of a project related to product development, process technology and design etc. which involves matter of secrecy and concern with security of the State and the Country, the same will not be allowed for publication / printing in any form such as electronically/verbal, etc. If the outcome of a project results into an intellectual property, for which rights can be secured, it will be decided on case to case basis. Similarly, sharing of expenditure in securing such rights and income accrued through royalty etc. by the parties under the law will be decided on case to case basis after mutual consultation.
- G. The Researchers from both the Parties, will be the authors in the publication/s, resulting from the collaborative work.

- H. Neither party will publish the work carried out under this MoU without knowledge of the other.
- I. In any of the activities mentioned above, wherever financial aspects are involved, amount, payment conditions, etc. would be spelt out clearly before starting the activity.

4. Other Areas:

- A. To exchange information on research and educational programs,
- B. To exchange information on teaching, learning material and other literature relevant to their educational and research programs,
- C. To jointly organize short-term continuing education programs on topics of mutual interest and to invite each other's staff to participate therein,
- D. To propose and engage jointly in research or training programs sponsored by funding agencies, and to invite each other's staff to participate therein.

5. Exchange of Knowledge and Staff:

- A. This MOU is intended, among other objectives, to foster increased interaction among the staff engaged in scientific and scholarly research, community based activities etc. in areas of mutual interest. In support of this effort, each party will promote the exchange of staff for short period of time so that they may become familiar with the facilities, methodologies, research culture and concern area of cooperation.
- B. As a general principle, funding for the exchange of such staff shall be based on self-expenses.

6. Intellectual Property Rights (IPR):

Ownership of any intellectual property (including but not limited to confidential information, know-how, patents, copyrights, design rights, rights relating to computer software, and any other industrial or intellectual property rights) developed jointly during the course of this MoU shall be vested in both parties to this Memorandum. Both parties shall have the joint right to determine the commercial exploitation and disposition of such intellectual property, and both parties shall make joint applications for the registration of the same. Before any registration or commercialization of any intellectual property takes place, the parties agree to reach a separate agreement covering issues such as exploitation rights and revenue sharing. Any publication regarding such intellectual property shall only be possible with the prior written consent of both parties, such consent not to be unreasonably withheld.

SVDU and MCT shall be free to use perpetually the results arising out of the collaborating activities for its own internal teaching, research, educational, clinical and publication purposes without the payment of royalties or other fees to the other party.

7. Amendments / Modifications:

This MoU will be amended / terminated with mutual consultations and written agreement, as and when needed.

8. Adherence to laws:

The participating staff and students involved in any activities under this Memorandum must adhere to the law of the country, and rules & regulations of both the parties.

9. Legal effect:

Nothing in this Memorandum shall be construed as creating any legal relationship between the parties. This Memorandum is a statement of intent to foster genuine and mutually beneficial collaboration.

10. Commencement and Tenure of MOU:

The present MoU shall become effective from the date of signing. It shall remain in force for the period of Ten (10) years i.e. from **14th July 2023 till 13th July 2033.**

11. Dispute Resolution:

Any dispute or difference arising out of or in connection with the interpretation or implementation of this MoU or out of or in connection with the breach, or alleged breach of this MoU, each Institution shall attempt in the first instance to resolve the conflict amicably by mutual agreement between the two representatives of the organization. Conflicts that cannot be resolved amicably shall be settled by arbitration.

This MoU is signed between Sumandeep Vidyapeeth Deemed to be University (SVDU) and Manahshrushthi Charitable Trust (MCT) on dated **14th July 2023.**
