Agreement

This Agreement is made and executed on this 1st day of July, 2021 at Baroda, by and between:

DocTutorials Edutech Private Limited having its office at 300A, MLA Colony, Road No-12, Banjara Hills, Hyderabad – 500034, a Company registered under the Provisions of Companies Act, 2013(Hereinafter called the "**DocTutorials**" of the FIRST PARTY, which term shall mean and include all its representatives, successors, executors, administrators, and assignees etc.,)

AND

S.B.K.S. Medical College and Research Institute, Sumandeep Vidyapeeth, Piparia Vadodara Gujarat represented by Registrar SVDU shall mean and includes his / her success or s and representatives as the 'SECOND PARTY'. WHEREAS the First Party is into Coaching for NEET PG, NEET SS aspirants and other entrance exams related to Medical Education. The medium of coaching would be digital namely videos, e learning modules through online app and offline classes teaching etc.

WHEREAS the Second Party has approached the First Party in engaging DocTutorials services and products and has approached the First Party. The First Party having enough experience has accepted to deliver the same and deliverables to the Second Party are as below.

IT IS HEREBY AGREED BETWEEN THE PARTIES HERETO AS FOLLOWS:

The college/Institute hereby engages DocTutorials to be an online, offline teaching and learning facilitator for NEET PG to the second party. DocTutorials will thereby fulfil the role and responsibilities as set out herein, in accordance with the terms of this Agreement and the College/Institute hereby accepts such engagement on the terms and conditions described herein.

2. Obligations of DocTutorials:

- (a) DocTutorials will arrange necessary Faculties to provide Online Live classes subject wise for SBKS MIRC medical students
- (b) Due to any reason if the Faculty is not available as per the schedule the DocTutorials will inform the management of College/institute one week prior and replace with another faculty. Otherwise all the logistics cost arranged will be borne by the DocTutorials.
- (c) All the students will be given the access to the App from the backend once DocTutorials receives payments from the students. The app subscription will be for a period of 1 year. This is in addition to Online Live Classes. The App will consist of pre-recorded lectures of all 19 subjects of NEET PG covering the entire syllabus, 50,000+ MCQs to practice including Grand Tests and monthly Subject tests.
- (d) DocTutorials will provide app support and 24 x 7 helpline to attend and clarify all technical and functional aspects of the app and ensure that the app services are functional 24 x 7.
- (e) The duration of the Online Live classes will be 30-35 days.
- (f) Classes will be conducted only on the weekend's i.e. Saturdays and Sundays or according to mutual understanding between both the parties.

3. Obligations of College/Institute:

- The College is responsible for arrangement of Faculty Class room, accommodation in Sumandeep Vidyapeeth campus, local travel (in Vadodara City) and food in campus if required.
- (b) The college will try to arrange appx. 300 students from Second Year and Third (First) Year. The price per student is INR 20,000/- + 18% GST.
- Any student from Final Year and Intern batch, who wants to join this program will be charged a similar amount i.e. INR 20,000/- + 18% GST over and above the figure mentioned in point 3(b).
- The college/institute should not promote any competitor online/offline platforms in the campus during the existence of this agreement.

4. Payment:

The payment will be made directly by the students to the first party.

5. Confidentiality

The College/Institute will, during the continuance of this Agreement and thereafter, observe strict secrecy as to the Confidential Information and will not, either during the continuance of this Agreement or thereafter, divulge such Confidential Information to any person without the prior written consent of the DocTutorials.

6. Nothing contained in this clause will apply to:

- a. information that is in the public domain;
- b. information which was known to the College/Institute prior to disclosure of such information by the DocTutorials; or
- c. information which the College/Institute is under a legal obligation to disclose to a court of law or other statutory/regulatory authority in which case, the College/Institute will:

- d. Return of Confidential Information: Upon DocTutorials's written request, the College/Institute will (a) return to DocTutorials any Confidential Information in the possession of the college/institute; and (b) immediately cease the use of any

7. Amendment to the Agreement

The obligation of the First Party and Second Party have been outlined in this agreement. However, during the operation of the agreement, circumstances may arise which call for alteration or modifications of this Agreement. These modifications/alterations will be mutually discussed and agreed upon in writing.

8. Period of Validity

- a) This agreement shall be initially valid for a period of 3 (Three) year from the date of signing the agreement and to be renewed subsequently by mutual consent of both the parties.
- b) The rates which are mentioned in Point 3(b) of the agreement are applicable for Year 1. The rates for Year 2 and Year 3 will be finalized by the end of the year 1 with a mutual agreement by both the parties.

9. Termination of Agreement:

- a. In the event of a breach of this Agreement by the other Party or where such breach is capable of cure and such breach has not been cured within 90 (Ninety) days' from issuance of notice intimating such breach.
- b. The college/institute can terminate the agreement only in the months of October, November and December of each calendar year.
- c. The first party can terminate the agreement only after completion of course (NEET PG) of running batch of each calendar year.

10. FORCE MAJEURE

Neither Party will be deemed to be in default of any provision of this Agreement or be liable for any delay, failure of performance or interruption of the provision of the Services to the other resulting, directly or indirectly, from any weather conditions, natural disasters or other acts of God or action of any governmental or military authority, civil unrest or commotion, fire, arson, terrorist act, etc.

11. GOVERNING LAW AND DISPUTE RESOLUTION

This Agreement will be governed by and construed in accordance with the laws of India. Subject to Clause 13 below, the courts at Hyderabad, India will have exclusive jurisdiction over matters arising from this Agreement.

12. All disputes or claims arising out of or in connection with this Agreement, including any questions regarding the interpretation, breach or validity of its provisions or its termination and/or any contractual obligations arising out of or in connection with this Agreement ("Dispute"), will be referred to arbitration in accordance with the Arbitration Act, 1996 before a sole arbitrator appointed on mutual consent. The place of arbitration will be Hyderabad and the language of the arbitral proceedings will be English. The award will be final and binding on the Parties and may be entered and enforced in any Court having jurisdiction at Hyderabad, India
