1. Preamble

1.1 About SVDU

2. Core Objective of this MOU -

To facilitate Healthcare Services, Academics, Education, Community and Social Service, Research etc. to Marginalized Sections of the societyincluding Tribal population, Divyangjan / Persons with Disability (PwD), Scheduled Caste, Scheduled Tribes, Other Backward Classes (including Economically Backward Sections), Senior Citizens / Old age persons, Women, Children of the Society, etc.

The collaboration between both the parties herein under, are based upon the principles of mutual interest.

3. Scope of Collaboration -

- 3.1 To jointly organize HealthcareScreening and Diagnostic Camps,Awareness programs on Self hygiene, Technical / Vocational Education,Environment, SwachhtaAbhiyan etc. onregular basis, at mutually agreed places, especially in semi urban, rural and tribal areas.
- 3.2 To provide healthcare services through mobile van "Arogyarath" forthe Marginalized Sections of the society including Tribal population, Divyangjan / Persons with Disability (PwD), Scheduled Caste, Scheduled Tribes, Other Backward Classes (including Economically Backward Sections), Senior Citizens / Old age persons, Women, Children of the Society, etc.
- 3.3 To undertake Research studies related to diseases, disorders and anomalies in tribal population.
- 3.4 To jointly undertake special program on 'Mother and Child Health' in tribal areas.
- 3.5 To undertake any other welfare program / activity, as identified from time to time.

- 4.1.3 Will provide medical and dental specialized services at Sumandeep Vidyapeeth Deemed to be University, at subsidized rate.
- 4.1.4 Will provide manpower for Research in tribal population and capacity building.

4.2 Shree Swaminarayan Mandir, Vadtal Sanchalit Shree Pancheshwar Mahadev Trust, Handod, Sankheda, Dist.-Chhotaudepur

- 4.2.1 Will undertake planning and execution of camps and other events, on mutually agreeable place and day.
- 4.2.2 Will provide required infrastructure at the site of camps and other events for organizing and execution of health camps.
- 4.2.3 Will undertake liasoning with village / local leaders / local NGOs / philanthropist etc. for organizing and successful execution of the health camp, any event etc.
- 4.2.4 Will support Academic, Educational, Research, Community Service etc. planned or organized by SVDU.
- 4.2.5 SSPM will support promotion of technical / vocational programs of SVDU to the schools / colleges in the tribal areas of Gujarat and neighboring State.
- 4.2.6 SSPM will provide hospitality (food, accommodation etc.) to the team of SVDU, during the conduction of health camps and other events.

5. Confidential Information -

- 5.1 Neither of the party will disclose / disseminate any confidential information related to patients and their disease, without mutual consent.
- 5.2 In case where the Government / Semi Government / Statutory Regulatory Authorities who are seeking information related to patient data, SSPM shall not provide the same.

6. Amendments / Modification -

This MoU may be amended or modified by a written agreement signed by the representatives of both the parties.

7. Governing Laws -

- 7.1 This MoU shall be interpreted, construed and enforced in accordance with the laws of India.
- 7.2 Any dispute or difference arising out of or in connection with the interpretation or implementation of this MoU or out of or in connection with the breach, or alleged breach of this MoU, each of the party / organization shall attempt in the first instance to resolve the conflict amicably by mutual agreement between the two representatives of the organization. Conflicts that cannot be resolved amicably shall be settled by arbitration.
- 7.3 In case of any arbitration, the jurisdiction shall be Waghodia / Vadodara only.
- 7.4 Either Party may terminate this MOU, at any time, upon thirty (30) days' of written notice to the other Party.

8. Use of Name -

The Parties shall either make use of this MOU, or use the name of the other Party (and not of any employee), in any publicity, advertising, news release etc., only after obtaining written consent of the other Party.

9. Intellectual Property Rights -

Ownership of any intellectual property, including but not limited to confidential Attested Cinformation, know-how, patents, copyrights, design rights, rights relating to computer software, and any other industrial or intellectual property rights developed jointly during the course of this MOU shall be vested in both parties to this Memorandum. Both parties shall have the joint right to determine the commercial
