#### About AAEC:

Allergy Asthma ENT Clinic (AAEC) has been a pioneer in establishing the first organized clinic dedicated to the science of Allergy & Immunology in Karnataka. It was established on the auspicious day of Vijayadashami, Aashvayuja maasa, 10<sup>th</sup> October 1978. Since its inception, under the leadership of Dr. Pendakur Anand, AAEC has been pursuing Clinical studies, collaborating to do research on clinical allergy and related aerobiology, updating colleagues on the emerging specialty, organizing seminars and conferences.

Phenomenal growth in the contribution by AAEC to the science of allergy commenced in 2016 when the first 'Advanced Course on Diagnosis of Allergy & Immunotherapy' was conducted in Bangalore. This national level physician training course provided the much needed training and certification of specialist medical doctors in the practice of clinical allergy & applied immunology. This pioneering and innovative initiative commenced in collaboration with Vydehi Institute of Medical Sciences & Research Centre, Bangalore, a reputed teaching institute. Since then every year, AAEC has been successfully conducting this course. Until now more than 350 specialist doctors have graduated and there is at least one certified allergy specialist in every state and union territory of India; and a very few in Nepal, UAE, Bangladesh, Sri Lanka, Maldives, Mauritius, Iraq and Nigeria.

The defined areas are Collaborative Academic / Educational value -added programs / courses, Research & Innovation Projects, Teaching Faculty & Student Exchange program, Faculty & Student development programs, Research Publications, other academic programs, conferences, workshops, etc., The core objectives comprise of:

# A. To conduct Value Added 'Advanced Course on Diagnosis of Allergy & Immunotherapy':

- Delegates / Participants: Medical colleagues from modern medicine with a postgraduatequalification, across the country and abroad and with a keen interest in the science of allergy.
- ii. Live Demonstrations and Hands-On Training in History taking, Clinical examination, Specific diagnosis of allergy and in particular Skin Prick Testing and in-Vitro diagnosis; Medical management of asthma and allergic conditions, and Allergen immunotherapy as a curative toolfor atopic diseases; will be the hallmark of the course.
- iii. Eloquent emphasis shall be on Allergen Detection and Immunotherapy; Adequate training with personal attention on practical training in both of these important components will be the target of teaching.
- iv. Live Demonstration of allergy causing House Dust Mites, Insect allergens, Pollen and Fungiwill be done using electron microscope and complimenting electronic devices; Real time Aerobiology Walk in the Open by the delegates with experts will showcase the source of allergy-causing Weeds, Grasses and Trees.
- v. Daily Yoga Practice and Hands-On Training in Therapeutic Yoga for the benefit of the delegates and for their patients.
- vi. SVDU will be the esteemed partner/collaborator in this endeavor.
- vii. SVDU shall be given due representation in the Prospectus / Program of the course, Brochure of the course, and in the Certificates with the signature of the Vice Chancellor or that of the authorized signatory whom the Vice Chancellor designates.
- viii. AAEC will provide necessary documents to SVDU and SVDU will make necessary applications to obtain approvals from Gujarat Medical Council certifying the Course as an accredited scientific program with credit hours.
- ix. Entire Budgeting, Registrations, collection of Fees, arranging Funds; Expenditure on Accommodation, Food and Beverages, arranging Audio-visual equipment and other electronic devices; expenditure on provision of text books and other course literature to the delegates and on the travel expenses and, Gifts and Honours done to the members of the faculty and to the Guests of Honour will be borne only by AAEC.
