Collaborative activities in the areas of Academic, Education, Social Service, Health Service and Research.

1. Preamble

1.1 About SVDU

Sumandeep Vidyapeeth, an Institution Deemed to be University (SVDU) is registered under Section 3 of UGC act 1956, is accredited by National Assessment and Accreditation Council (NAAC) at 'A' Grade with CGPA 3.53 at Four-point scale, and is conferred Category-I Deemed to be University status by University Grants Commission (UGC). The Institution has various constituent institutes like K. M. Shah Dental College & Hospital, SBKS Medical Institute & Research Centre, Department of Pharmacy, Sumandeep Nursing College, College of Physiotherapy, Department of Management, Department of Public Health and College of Rehabilitation Sciences. All these institutes are approved/recognized by the respective Statutory Regulatory Authorities and Government of India.

The Institution has numerous Research Thematic areas such as Oral Cancer, Oral Diseases, Neurological Disorders, Immunological Disorders, Sickle Cell Anemia, Diabetes Mellitus, Tuberculosis, Parasitic Infestation, Maternal & Child Health, General Rehabilitation, Drug Discovery, Targeted Drug Delivery etc.

The Institution has multi-speciality Medical and Dental hospital that caters to the need of local population and is the major source of Clinical Research. These hospitals are enriched with patients with different types of diseases and anomalies.

As part of SVDU's commitment and to achieve the motto of social development the University in its ISR policy was designed with an objective to build socially responsible health professionals and social development through improving the General Health Condition and Educational status of the community around the campus and beyond as specially of tribal and most neglected communities.

As part of its responsibility towards the society, SVDU organize Multi Speciality Health Camps, Oral Health Camps, Special Health Camps like Breast, Cervical and Oral Cancer Camps, Awareness Generation program on important health issues in collaboration with NGOs/CBOs and Government Health Machineries in remote, hard to reach, underserved areas of Gujarat, Madhya Pradesh and Rajasthan as per the local needs.

SVDU also provide educational support in kind like books, uniform, school bags, school fees etc. to school going children especially from Jain Community, from near by vicinity. The Institution also gives priority and Free-ships / Scholarships / complete waiver in fees to the students from tribal areas. The children's of employees from category C and D are provided financial support for professional education under the scheme 'Gyanvardhak Scholarship Scheme'. From couple of years, 15 students of the marginalized section of the Society, especially from tribal zone, who were recommended by Bharat Vikas Parishad, were provided with complete free-ship for undergoing professional courses in Paramedical Sciences.

1.2 About Bharat Vikas Parishad, Ahmedabad

Bharat Vikas Parishad (BVP) is a voluntary organization where citizens from all walks of life join to work for the development and growth of our country in all fields of human endeavour through promoting a sense of patriotism, national unity and integrity and culminating in Swasth-Samarth-Sanskrit Bharat i.e. physically, economically and morally strong India. The work scope of the organization mainly focuses on Service (sewa) and Educational (sanskar). There are total 1630 branches all over the country of BVP, including 75 branches in Gujarat, out of which 20 branches are in Ahmedabad.

Service:

The organization serves the Divyang / Persons with Disability (PwD), by providing selfmanufactured artificial limbs; taking up integrated village development of over 65 villages all over the country (providing tube-wells for water supply, toilets, constructing / renovating ponds, pathways, drains, class rooms, temples and even common crematoria), helping the tribal brethren, protecting environment by planting trees, organizing health checkup and yoga camps, blood donation, setting up super specialty hospital and diagnostic centers, and whenever there is a national calamity, provide necessary help and undertake relief measures are some of the important Service projects. Our social campaigns include Beti Bachao - Beti Padhao and Nasha Mukti. They also organize mass marriages for poor young girls and boys and sanskar shivir for the students, women and the elderly and seminars for the youth.

Educational:

This organization undertakes regular Sanskar projects for the students, youth, women and the elderly. For the students, programs such as Bharat Ko Jano quiz competition and chorus singing of patriotic songs competition are organized in schools where students offer respect to teachers. Students from colleges and professional institutes also participate in online Bharat Ko Jano quiz programmes.

2. Core Objective of this MOU -

The specific purpose of this MOU is to facilitate Academic, Education, Social Service, Health Service and Research etc. for Marginalized Sections of the society, including Divyangjan / Persons with Disability (PwD), Schedule Caste, Schedule Tribes, Other Backward Classes (including Economically Backward Sections), Senior Citizens / Old age persons of the Society, etc. The collaboration between both the parties herein under, are based upon the principles of mutual interest.

3. Scope of Collaboration -

- 3.1 To jointly organize Health Camps on regular basis at places mutually agreed to provide health care to rural, peri urban, urban and tribal areas.
- 3.2 To provide healthcare services for Divyangjan / Persons with Disability (PwD), Schedule Caste, Schedule Tribes, Other Backward Classes (including Economically Backward Sections), Senior Citizens / Old age persons of the Society, etc.
- 3.3 To serve the Divyang / Persons with Disability (PwD), by providing free Health services including distribution of Artificial Limbs, Hearing Aid, Obturators and any other Artificial appliances.
- 3.4 To conduct / provide Educational Training in the areas of Paramedical Sciences / Skill Development Programs, on complete Freeship / Scholarship / Waiver in Educational & Examination Fees, Lodging and Boarding, Internet Facilities, Learning Resources and Sports Facilities; to the eligible students from Schedule Caste / Schedule Tribe / Economically Backward Section, who are recommended by BVP.
- 3.5 To implement Student exchange programmes in order to gain knowledge on local health issues and identify areas for research topics.
- 3.6 To conduct in-house trainings on various skill development courses, for mutually identified youths.
- 3.7 To create and provide Job opportunities as per the prevailing norms of Sumandeep Vidyapeeth for eligible candidates from tribal and marginalized sections of the society.
- 3.8 To undertake Research on the subjects of mutual interest.
- 3.9 Any new area of collaboration can be identified and included under this MoU on mutually agreed terms, as and when required.

4. Roles and Responsibilities of Parties -

4.1 For Sumandeep Vidyapeeth:

- 4.1.1 Will depute Health Consultants, Residents, Interns for Health camps at mutually agreed place and for collaborative research.
- 4.1.2 Will provide free admissions to the deserving students in the skill development courses, especially in Paramedical Sciences, only after fulfilling the eligibility criteria prescribed by Statutory Regulatory Authorities, if any and based on the available seats. The students will be offered complete free-ship for all types of educational fees, lodging and boarding fees, educational support system and physical education.

4.1.3 Will provide required infrastructure / facilities for the students and patients especially from Marginalized Sections of the society, including Divyangjan / Persons with Disability (PwD), Schedule Caste, Schedule Tribes, Other Backward Classes (including Economically Backward Sections) and Old persons of the society.

4.2 For Bharat Vikas Parishad (BVP):

- 4.2.1 BVP will organize camps at its own cost at mutually agreed place.
- 4.2.2 BVP will support Collaborative Research.
- 4.2.3 BVP shall ensure that, the students shall maintain utmost decorum during the course of study, and shall abide by the prevailing rules / regulation of SVDU. In case of breach, the final decision of the authorities of SVDU is binding.

5. Confidential Information -

- 5.1 No party will disseminate any information of students who are enrolled in free-ship scheme or health records of individual or individual information collected for the purpose of research etc. without mutual consent.
- 5.2 In case where the Government / Semi Government / Statutory Regulatory Authorities who are seeking information as specified in above clause 1, the parties are liable to provide the information, only after seeking written consent, from either of the party.

6. Amendments / Modification -

This MoU may be amended or modified by a written agreement signed by the representatives of both the parties.

7. Governing Laws -

- 7.1 This MoU shall be interpreted, construed and enforced in accordance with the laws of India.
- 7.2 Any dispute or difference arising out of or in connection with the interpretation or implementation of this MoU or out of or in connection with the breach, or alleged breach of this MoU, each of the party / organization shall attempt in the first instance to resolve the conflict amicably by mutual agreement between the two representatives of the organization. Conflicts that cannot be resolved amicably shall be settled by arbitration.
- 7.3 In case of any arbitration, the jurisdiction shall be Waghodia / Vadodara only.
- 7.4 Either Party may terminate this MOU, at any time, upon thirty (30) days' of written notice to the other Party.

8. Use of Name -

The Parties shall either make use of this MOU, or use the name of the other Party (and not of any employee), in any publicity, advertising, news release etc., only after obtaining written consent of the other Party.

9. Intellectual Property Rights -

Ownership of any intellectual property, including but not limited to confidential information, know-how, patents, copyrights, design rights, rights relating to computer

software, and any other industrial or intellectual property rights developed jointly during the course of this MOU shall be vested in both parties to this Memorandum. Both parties shall have the joint right to determine the commercial exploitation and disposition of such intellectual property, and both parties shall make joint applications for the registration of the same. Before any registration or commercialization of any intellectual property takes place, the parties agree to reach a separate agreement covering issues such as exploitation rights and revenue sharing. Any publication regarding such intellectual property shall only be possible with the prior written consent of both parties, such consent not to be unreasonably withheld
