

Avalon World School, Waghodia Road, Piparia, Vadodara (hereinafter referred to as **AWS**)

This MoU is for establishing the Collaboration between SVDU and AWS in the areas of Academic, Education, Social Service, Health Service and Research.

Preamble

1. About Sumandeep Vidyapeeth Deemed to be University:

Sumandeep Vidyapeeth Deemed to be University (SVDU) is registered under Section 3 of UGC act 1956, is accredited by National Assessment and Accreditation Council (NAAC) at 'A' Grade with CGPA 3.53 at Four-point scale, and is conferred Category-I Deemed to be University status by University Grants Commission (UGC). The Institution has various constituent institutes like Smt. B.K.Shah Medical Institute & Research Centre (SBKSMIRC), K. M. Shah Dental College & Hospital, Department of Pharmacy, Sumandeep Nursing College, College of Physiotherapy, College of Rehabilitation Sciences, Department of Public Health and Department of Management. All these Institutes are approved / recognized by the respective Statutory Regulatory Authorities and Government of India.

The Institution has 1100 bedded Dhiraj Hospital, 350 Hi-tech Dental Chair Hospital, State of the art Labdhi Simulation Center (LSC) etc.

2. About Avalon World School:

Children need space to spread their wings. The designers and planners of Avalon World School Waghodia Road, kept that in mind as the schools abode took shape in the year 2016 and is affiliated to the CBSE Board. The School is run by Sanskriti Educational Society, Delhi. There are six schools in the Sanskriti Group namely DPS-Vadodara, DPS-Harni, DPS-Bharuch, DPS-Anand, AWS-Waghodia and AWS-Dabhoi.

Scope of the Collaboration

The activity will be jointly conducted between SVDU and AWS, with defined areas. The core objectives comprise of:-

- To train young students in Compression Life support and to incorporate in young minds ability to save life. The present collaboration with mutual interest, may conduct trainings on Compression Only Life support for students of class V to X.
- 2. SVDU shall organize and conduct General Health check-up camps for the children of AWS, either in the campus of AWS or at the Hospitals associated with SVDU. The Health check-up camps activity will be free of cost. Also, SVDU will conduct Health awareness programs for the Students and Teachers of the School, on periodic basis. The Health check-up camps will include Dental and Oral Health check-ups by the Dental Surgeons, General Health check-up camps by Pediatricians of SVDU. These programs will be jointly organized on regular basis, at places mutually agreed to provide health care to rural, peri urban and tribal areas.
- To provide healthcare services for Divyangjan / Persons with Disability (PwD), Schedule Caste, Schedule Tribes, Other Backward Classes (including Economically Backward Sections), Senior Citizens / Old age persons of the Society, etc. to Rural, Semi Urban and Tribal areas.
- 4. To serve the Divyang / Persons with Disability (PwD), by providing free Health services including distribution of Artificial Limbs, Hearing Aid, Obturators and any other Artificial appliances.
- 5. To conduct in-house trainings on various skill development courses, for mutually identified youths.
- 6. To create and provide Job opportunities as per the prevailing norms of Sumandeep Vidyapeeth Deemed to be University for eligible candidates PwD, Tribal and Marginalized Sections of the Society.
- To undertake Research on the subject/s of mutual interest.
- 8. Any new area of collaboration can be identified and included under this MoU on mutually agreed terms, as and when required.

General Areas of Cooperation:

This MOU details the modalities and general conditions regarding collaboration between SVDU and AWS for enhancing, within the country, the availability of highly qualified manpower in the areas of training with simulation without any prejudice to prevailing rules and regulations of SVDU and AWS, without any disregard to any mechanism evolved and approved by the competent authorities under Govt. of India in so far as such mechanism applies to SVDU and AWS.

Further, the general areas of Cooperation will also include General Health check-up and Health Awareness, Research, Social Service, Education; and can be extended through mutual consent.

Confidential Information -

SVDU does not absolve any confidential information during the activity.

Intellectual Property Rights -

Ownership of any intellectual property (including but not limited to confidential information, know-how, patents, copyrights, design rights, rights relating to computer software, and any other industrial or intellectual property rights) developed jointly during the course of this MOU shall be vested in both parties to this Memorandum. Both parties shall have the joint right to determine the commercial exploitation and disposition of such intellectual property, and both parties shall make joint applications for the registration of the same. Before any registration or commercialization of any intellectual property takes place, the parties agree to reach a separate agreement covering issues such as exploitation rights and revenue sharing.

Any publication regarding such intellectual property shall only be possible with the prior written consent of both parties, such consent not to be unreasonably withheld.

SVDU shall be free to use perpetually the results arising out of the collaborating activities for its own internal teaching, research, educational, clinical and publication purposes without the payment of royalties or other fees to the other party.

Amendments/Modifications -

This MoU may be amended or modified by a written agreement signed by the representatives of both parties.

Adherence to Laws -

Participating Teaching Faculties, Non-Teaching Staff and Students involved in any activities under this Memorandum must adhere to the law of land, and rules and regulations of both the Institutions.

Legal Effect -

Nothing in this Memorandum has any legal liability on both the parties.

Commencement and Tenure of MOU:

The present MoU shall become effective from the date of signing, i.e. October 2020 till October 2030, for the period of Ten (10) years. This MoU will be renewed / amended / terminated with mutual consent and written agreement.

Dispute Resolution:

This memorandum is only for training the students for Compression Only Life Support, and conducting General Health and Dental Health check-ups and awareness programs to the students. Any disputes need to be resolved mutually. In case either of the party does not want the training to be continued, the MOU shall be terminated by providing prior information, atleast 30 days in advance.

SVDU and AWS have consented for this Memorandum, for cooperation and jointly agrees to the

provisions as set out above.
