- * Will have the right to shift or close the Programme Study Centre if it finds that support services are not being provided, as per the requirements. In such case, the PSC would have to hand over academic records of the learners and other materials to SIHFW.

2.The Program Study Centre (PSC) will:

- * Recommend and finalized name of Program-in-Charge to IIPHG
- * Make halls/rooms available for holding counselling sessions of the course and course examinations.
- * Extend library, laboratory, computer facilities, etc. to course students for the given program on mutually agreed terms.
- * Conduct the theory and practical examination of the course as per defined norms and concurrence with IIPHG guideline
- * Maintain the records of attendance, internals and feedback of students and submit it to IIPHG as per requirement
- * Submit result of theory and practical examination to IIPHG as per the guidelines
- * Have to ensure that all the counselors for the course should meet the guideline of having post graduate degree OR graduate degree with minimum 5 years of experience of work in the literate caching/Program management

*Submit any financial requirement regarding course to SIHFW

* Coordinate with Program-in-Charge (PIC) suggested by the head of the PSC institution for operationalization of course at host institute.

*Provide study material including printed copies of modules to the participants and

study centers as per requirement of PSC.
