(individually "Party", together "Parties")

1 PURPOSE

- 1.1 The Parties recognise that each of them is pursuing educational, research, cultural and training activities in areas of possible common interest and that there may be mutual benefit in cooperating or collaborating in such activities.
- 1.2 The Parties wish to discuss the possibility of establishing a collaborative relationship between them for educational activities and collaborations to promote the sharing of knowledge, exchange of information and experiences for staff and students.

2. INTENT

2.1 The Parties will endeavour to promote cooperation and collaboration between them.

3 OPERATION

3.1 The Parties agree that any collaborative relationship will be subject to formal legal Collaboration Agreement between the parties.

Any areas of cooperation must first be approved by the Vice-Chancellor or other Director of each Party or their authorised delegate.

The formal Agreements described in 3.1 and 3.2 above must be in writing and signed by duly authorized the presentatives of each Party.

4 GENERAL PRINCIPLES

- 4.1 Collaboration between the Parties must be subject to mutual consent, be feasible and desirable for both Parties.
- 4.2 There must be demonstrable mutual benefit to each Party.
- 4.3 There must be mutual respect between the Parties and any staff or students in any way involved in the collaboration.
- 4.4 Neither Party shall do or say anything which may bring the name or reputation of the other Party into disrepute.
- 4.5 There is no obligation on either Party to enter into any further Collaboration Agreement or to enter into any form of collaboration.

5 CONFIDENTIALITY

Each Party agrees to treat as confidential and maintain in confidence all information of a confidential, sensitive or proprietary nature which may be disclosed or revealed to it as a result of this Memorandum of Intent.

6 DURATION

This Memorandum shall take immediate effect and shall continue until either:

- i) the Parties agree that there is no mutual benefit in or possibilities for collaboration; or
- ii) either Party serves to the other 6 month's notice to terminate this Memorandum.

7 LEGAL EFFECT

The Parties agree that except as set out in clause 5 above this Memorandum is a statement of intent and of current intentions and is not intended to create binding or legal obligations on either Party.
