This MoU is for establishing the collaboration between SVDU and AT, especially for Persons with Disabilities (PwD), in the areas of Rehabilitation Services, Health Care Services, Collaborative Research and Innovation Projects / Studies, Collaborative Programs / Courses, Incubation Centre, Startups, Community / Social Service, Collaborative Health checkup and Treatment camps, Collaborative Conferences / Seminars / workshop etc. The collaboration between both the parties herein under, is based upon the principles of mutual interest for societal upliftment and Nation building.

Preamble

About SVDU:

Sumandeep Vidyapeeth Deemed to be University was notified through Gazette Notification of Ministry of Human Resource Development (MHRD), Department of Higher Education, Government of India, through vide notification No.F.9-46/2004-U.3 dated17th January 2007, as 'Deemed to be University' under de novo category. The Vidyapeeth was established under Section 3 of the University Grants Commission

Attested CT(UGC) Act, 1956 through vide Notification No. F.No.6-106/2004 (CPP-1) dated 9th March 2007, and vide Notification No. F.6-106(1)/2004 (CPP-I) dated 26th August 2008.> The MHRD through its notification no. F.9-46/2004-U.3

16th December 2019, has extended the 'Deemed to be University status' for Sumandeep Vidyapeeth Deemed to be University, from 17th January 2012 onwards.

About Department of Audiology and Speech Language Pathology, SVDU:

Department of Audiology and Speech Language Pathology (DASLP), constituent Department of Sumandeep Vidyapeeth Deemed to be University was established in the year 2019, with due permission of Rehabilitation Council of India (RCI). The Department offers Educational Programmes in Bachelor of Audiology and Speech Language Pathology (B. ASLP), Diploma in Hearing Aid Repair and Ear Mould Technology (DHAREMT) and Ph.D. in Audiology & Speech Language Pathology. In near future, Master's program in Audiology & Speech Language Pathology will be started.

The Clinical Section of the Department undertakes Rehabilitation Services for Persons with Hearing and Speech Language Disability, from more than 20 years at Dhiraj Hospital, SBKSMIRC. The Rehabilitation services in the hospital does not limit to the following: (1) Evaluation and treatment of hearing loss and tinnitus (2) Assessment and Rehabilitation of auditory and balance disorder (3) Provision of hearing aids, assistive and alerting devices (4) Post Cochlear Implant management (5) Evaluation and treatment of speech, language, voice, and swallowing disorders (6) Rehabilitation for Speech Language Pathology.

About AT

Akshar Trust is a non-profit voluntary organization registered under the Bombay Public Trust Act 1950, bearing No. E/4063/Vadodara dated 29.03.1989. The Trust began its activities with 5 hearing impaired/deaf children on 18th July 1988 in a small, rented shed in Fatehsinghrao Gymkhana. It is today educating 118 children with a staff of 30, including teachers. The teacher training course started in 1999 and 356 teachers have been trained till date. It has worked to provide hearing impaired children an opportunity to be educated and thus be employed and independent. Akshar Trust prefers total communication mode to teach children. It is the only school, out of 38, for the deaf in Gujarat, which also offers Hindi as a separate medium of instruction, apart from Gujarati. The Rehabilitation Council of India (RCI) has given 'permanent Recognition' to the Teacher Training Programme and has accorded 'very Good Performance' status to the programme in 2009. Akshar Trust has conducted 20 CRE programmes under RCI,

Capacity building and services for Persons with Disabilities (PwD), in the focused areas, such as Rehabilitation Services especially in hearing & speech impairment, Health Care Services, Collaborative Research and Innovation Projects / Studies, Collaborative Programs / Courses, Incubation Centre, Startups, Community / Social Service, Collaborative Health checkup and Treatment camps, Collaborative Conferences / Seminars / workshop etc.

General Areas of Cooperation

This MoU will govern the relationship between the SVDU and AT regarding Rehabilitation Services to Persons with Disabilities (PwD) of any age.

Both SVDU and AT shall encourage interactions among Clinicians, Teaching Faculty members, Non-Teaching Staff, Students and Children / Patients through the following arrangements, but not limited to:

- 1. For providing and making the Rehabilitation services available to Persons with Disabilities (PwD), including Hearing and Speech Language disorders.
- 2. Clinical Screening and Assessment of various Impairments in PwD and normal individuals.
- 3. Medical and Rehabilitation camps to be organized jointly for PwD and normal individuals, if any.
- 4. To jointly participate in the development of an individual education program for school age children.
- To undertake research projects / studies as needed for PwD.
- 6. To undertake or device new aids / equipment's required for Persons with Disabilities (PwD), and to Patent / Copyright the same, either individually or jointly.
- 7. Research, Innovation, Startup etc. shall be undertaken in the campus of Sumandeep Vidyapeeth Deemed to be University, in relation to Persons with Disabilities (PwD).

Confidential Information

SVDU and AT agree for not disclosing any type of confidential material, knowledge, study results or information. The parties may like to share this with one another but may decide not to disclose it to any third party. In the event if it is required to be shared with a third party, except as an when required by law; then mutual consent in writing must be

Amendments / Modifications

This MoU may be amended or modified by a written agreement signed by their representatives of both parties.

Adherence to Laws

Participating Teaching Faculties, Non-Teaching staff and students involved in any activities under this Memorandum must adhere to the law of the country and rules and regulations of the Institution.

Legal Effect

Nothing in this Memorandum shall be construed as creating any legal relationship between the parties. This Memorandum is a statement of intent to foster genuine and mutually beneficial collaboration.

Commencement and Tenure of MOU

The present MoU shall become effective from the date of signing. It shall remain in force Attested Gof the period of Five (5) years i.e. from 15th July 2022 till 14th July 2027. This MoU will be amended / terminated with mutual consultations and written agreement, as and

when needed.
