

The IQAC of the Institution has conducted programs such as National Symposium on "National Education Policy- 2020", Orientation and Sensitization Program on NAAC Accreditation Process, Annual Quality Assurance Report (AQAR) & Self Study Report (SSR), National Symposium on Quality Research during Digital Era.
- The Cell promotes quality enhancement for institutional functioning through quality culture and institutionalization of best practices.
