Sumandeep Vidyapeeth utilizes management information system in all its areas of operations under various heads as described below: 1. Planning and Development: Institutional Website is put in to full use as a vital information source to all the stakeholders and all important circulars/ notices are made available in website.	

Institution also invites and publishes tender applications through institutional website. Application form and document upload for job application is facilitated by ERP module. Planning, upgradation of facilities and maintenance related complaints is also handled through Institutional ERP.

2. Administration: Institution has biometric attendance management system to track timely reporting of employees. The ERP module of Biometric attendance Management has various features such as individual overall employee report, monthly report, leave reports, etc. Institution has in house developed Hospital Management Software (HMS) for both Dhiraj General Hospital and K. M. Shah Dental College and Hospital. The Hospital Management Software has features such as Inpatient and Outpatient Management, management information System Report, laboratory Report Generation and Record, Operator wise Summary Report Management and payment Management

3. Finance and Accounts: Institution has continued Licensing of Tally Software to handle accounting, inventory management, tax management, payroll etc. Institution has also implemented fee collection management in ERP for admission fees collection, registration of alumni association and registration for the convocation.

4. Student Admission and Support: Institution has completely automated online application and admission system and it includes Admission enquiry, Enquiry follow up, Online application forms, Generation of merit list, Document verification, Seat Allotment, Tuition fees payment, Generation of Admission letter, Generation of Enrollment Number etc. It also allows uploading of scanned documents required for the admission process. Applicant can register on institutional website and sign in to apply for admission. It also has the inquiry and query portal for admission process. For student support the website hosts portal in which complaints and queries can be registered under various heads. Institution has its own Library repository where various econtents are uploaded regularly by the teaching faculty, which can be accessed by students for further studies. Institution has also renewed the licensing of various educational softwares like DelNet, Micro MedEx and UptoDate database. Institution has Urkund online anti Plagiarism software to maintain the quality of research work.

5. Examination: Institution has in house tailored made Examination Management Software for examination evaluation process, result and report generation. Processing of Result, Issuing mark sheets, degree certificates, Examination fees payment, Application for Convocation is automated through ERP.

### 15. Multidisciplinary / interdisciplinary

Sumandeep Vidyapeeth Deemed to be University is a large Multidisciplinary teaching intensive Institution with ten health

care constituent Institutes and offered 130 programs under Medical, Dental, Physiotherapy, Nursing, Pharmacy, Ayurved, Homoeopathy, Management (Health Care), Audiology and Speech Language Pathology, and Paramedical sciences in the academic year 2022-23. The entire Institution runs like an integrated higher education system, catering to professional and vocational education of the students enrolled. All the constituent institutes exist in the same campus and function like a cluster for multidisciplinary approach. There is a separate established literary, arts and cultural committee, well established department of sports and physical education catering to both outdoor and indoor games and sports, a yoga centre. As the institution is a Jain Minority Institution, it has establishing a department focusing on Jain culture and practices. To offer multidisciplinary programmes successfully, the constituent institutes conduct student-induction programmes to create awareness among students about various learning pathways and career opportunities. Sumandeep Vidyapeeth is registered in the Academic Bank of Credit (ABC); and is in the process of identifying programs where the adoption of online courses is possible, in addition to looking out for collaborations with other HEIs, to offer the programmes with a strong interdisciplinary flavor. However, the Institution is facing difficulty in designing programs for dual degrees as most of the programs are governed by statutory councils. Students entering the portals of Sumandeep Vidyapeeth get proper guidance and orientation about the available programs and opportunities, setting pace of their academic journey. Faculty and students are also guided and encouraged to take up online courses on SWAYAM portal which provides an ideal platform for multidisciplinary education system. Most of the programs offered in the Institution involves teaching by faculty of different departments and are Multidisciplinary in nature. The offered programs in the Institution are skill based and are punctuated with internship, community service and engagement and all the faculty are well qualified, trained and updated in their field. The Institution has an active Competitive Examinations and Career Advancement Cell which offers training to students for appearing in various competitive examinations and gives guidance for advancement of their career. The established placement cell facilitates processes to identify employment opportunities and set up interactions with potential employers. The academic section is well established which contributes to multidisciplinary and holistic education and to research and development in these areas. Sumandeep Vidyapeeth has more than adequate educational infrastructure in terms of books, journals, study materials, audio-visual facilities, e-resources, virtual classrooms, studios and specifically, high bandwidth internet connectivity to deliver courses through hybrid mode.

**16.Academic bank of credits (ABC):**

Sumandeep Vidyapeeth is registered with Academic Bank of Credits and is working on the process of implementing it, to facilitate students for multiple entry-multiple exit as well as any-time, any-where, and any-level in the programs wherever possible. However, there are limitations on the institution as most of the programs come under health care sector which are strictly governed by statutory regulatory bodies, which have not yet given specific directions for implementation of Credit transfer, Credit accrual and Credit redemption through Academic Bank of Credits for the programs governed by them.

**17.Skill development:**

The Institution focuses on professional skill development of the students as all the programs offered are skill based. All the constituent Institutes have pre clinical and clinical skill development labs consisting of training models and simulators in all the relevant departments, which are extensively used by students and teachers for the development of clinical skills. The Institution has specialized skill development centre 'Labdhi' which is equipped with high fidelity mannequins. It has one seminar room and six demo rooms. There are different models of Mannequins for techniques like central line insertion, arterial line insertion, injection administrations, advanced airway, tracheostomy, inter costal drain insertion, labor procedure etc. for mastery of skills simulating real life circumstances. American Heart Association approved certificate courses on Basic Life Support (BLS) and Advance Cardiac Life Support (ACLS) are periodically conducted in the centre for the students as well as faculty in collaboration with Indian Institute of Emergency Medical Services.

**18.Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)**

The institution in its pursuit of Indian Knowledge System has started Sumandeep Ayurved Medical College and Hospital and Department of Jain Philosophy and Research. There are separate established literary, arts and cultural committee and a yoga centre. A separate teacher is employed to teach Sanskrit for the students of Sumandeep Ayurved Medical College and Hospital.

**19.Focus on Outcome based education (OBE):Focus on Outcome based education (OBE):**

Sumandeep Vidyapeeth focuses on Outcome Based Education. All the programs of the Institution have clearly stated learning outcomes in the form of and as stipulated by the applicable regulatory bodies.

All these outcomes are achieved by the students along with value additions when they complete the course. The faculties responsibly train the students to achieve stated learning outcomes so that the students are ready to accept the local, regional, national and global challenges in their relevant field through various modes including problem based learning and evidence based journal clubs. Assessment of the achievement of stated objectives in learning outcome and graduate attributes are done for each program/course systematically keeping in mind the parameters to be measured. Teaching schedule is planned as per program/course outcomes to be achieved. The academic programs offered by all the constituent Institutes are designed to meet the changing needs in the health care fields. Curriculum followed in every program offered by the institution focuses on competency, employability, entrepreneurship and skill development. The curricula are frequently enriched on the basis of feedbacks received from all the stakeholders which includes Teachers, Students, Employers and Professionals. The curricula offered across all programs were revised during the last five years. To cater to the changing needs of the stakeholders in health sector globally and to make every healthcare professional a lifelong learner Evidence Based Practice (EBP) is the main requirement. Hence one of the primary goals of Sumandeep Vidyapeeth is to impart principles and processes of Evidence-Based Education System to the students. To achieve the same, the curriculum of every program is incorporated with teaching of evidence-based subjects in both Undergraduate and Postgraduate programs. Progress towards achievement of learning outcomes is assessed using internal assessments through MCQ evaluations, tutorials; project works, continuous evaluations etc. Being formative in nature the institutes have customized the internal assessments\ according to the statute guidelines with value additions to gauge the academic progress of the students. Continuous Cumulative Evaluation system (CCES), Mentorship program, self assessment and workplace based assessment are also in place.

#### **20.Distance education/online education:**

The Sumandeep Vidapeeth has not offered any distance education or online education programs as all the programs offered are health care related and no specific guidelines were given by the regulatory bodies governing the programs. However, keeping NEP 2020 in mind, courses that will be permitted in online and distance education modes will be instituted.

#### 1.1 - Curriculum Design and Development

1.1.1 - Curricula developed and implemented have relevance to the local, national, regional and global health care needs which are visible in Programme Outcomes (POs), and Course Outcomes (COs) offered by the University, as per the norms of the Regulatory Bodies.

The Institution imparts quality medical education and training, and provides scientific, evidence-based health care knowledge, leading to a life time learning of ethical practice and community-oriented research.

Curricula developed and implemented:

Curriculum followed in every program offered by the institution focuses on competency, employability, entrepreneurship and skill development. The curricula are frequently enriched on the basis of feedbacks received from all the stakeholders. The curriculum provides special importance to the requirements of stakeholders without compromising on the regulatory requirements and to keep the curricula updated regularly by considering the local, national, regional and global needs, which is achieved through:

a. Evidence Based Practice: Curriculum of every undergraduate program is incorporated with teaching of evidence-based subjects. The Postgraduate programs incorporate EBP in their routine presentations of journal clubs, seminars, case presentations and clinical practice for diagnosis and management of the diseases.

b. Skill based Learning: A state-of-the-art Skill lab in the campus provides American Heart Association approved Basic Life Support (BLS) and Advance Cardiac Life Support (ACLS) certifications.

c. Online Teaching System and Digital Lab: The digital media lab with Lecture capturing system enables developing educational materials and recording the lecture sessions for building efficient teaching learning system.

Sumandeep Vidyapeeth adopts diverse student-centered teaching and learning methodologies.

The institution employs experiential learning by enabling students to participate in local, regional, national, and international events. Additionally, clinical meetings are regularly organized to promote integrated and interdisciplinary learning among faculty and students from different disciplines.

Participatory learning is also emphasized, where students engage in group discussions, journal club presentations, seminars, debate competitions, and various community activities.

Problem-solving methodologies such as case-based and problem-based learning are incorporated into the academic schedule, while self-directed learning is facilitated through access to e-books and e-journals from the institutional repository.

The institution prioritizes patient-centric and evidence-based learning, through the unique Evidence-Based Education System (EBES) incorporated into lectures and clinical treatment planning. Furthermore, the humanities are taught through the integration of attitude, ethics, and communication.

Project-based learning is facilitated through the community-based EviGenChIP project and other research activities. Finally, the traditional method of taking case history is modified to a role-play method, where faculty and students engage in an enactment.

The institution has implemented various processes and procedures to ensure an efficient and effective examination process.

The institution uses URKUND plagiarism check software to evaluate all the PG and PhD dissertations.

Students are assessed for their competency-based learning outcomes in various areas like Direct Observation of Procedural Skills (DOPS) used in BLS and ACLS training programs, Objectively Structured Video Examinations (OSVE), Objectively Structured Clinical Examinations (OSCE), and Objectively Structured Practical Examinations (OSPE).

Some of the reforms implemented in the academic year 2022-23:

- Examination of the student in the subject in which he/she is caught involved in unfair practice should only be declared null and void and the student shall not appear in the examination of the same subject for six months. However depending on the severity of unfair practice the decision of unfair means committee upon approval of the Honourable Vice Chancellor shall be final and binding.

Two broad types of assessment methods are used for this purpose:

The first one is formative assessment, which involves continuous and ongoing assessment of students' academic performance. This includes internal examinations such as preliminary examinations, which assess students' academic performance in theory, practical, and viva-voce examinations.

The Continuous Cumulative Evaluation System (CCES) is also used, which involves various evidence-based seminars, case presentations, quiz competitions, journal club meetings, maintenance of logbooks, record of attendance, day-to-day credits in the hospital and theory/practical classes, MCQs, assignments, clinical end-posting exams, etc.

The second assessment method is summative evaluation, which is the final evaluation of students at the end of the year, term, semester, or course. This evaluation method determines the final grade or result for the students.

## INFRASTRUCTURE AND LEARNING RESOURCES

### 4.1 - Physical Facilities

4.1.1 - The Institution has adequate physical facilities for teaching –learning, skills acquisition etc.

All constituent institutes of the Institution provide teaching and learning facilities, laboratories, and skill labs in accordance with regulatory bodies' requirements.

Dhiraj Hospital, attached to SBKS Medical Institute and Research Center, is a 1400 bedded super-specialty teaching hospital. The Institute has Rural Health Training Center at Bahadarpur and Urban Health Training Center at Kothi.

K.M. Shah Dental College and Hospital is equipped with 350 dental chairs and 34 clinics and laboratories. Preclinical learning is facilitated through simulative labs, phantom heads, and working models.

The Department of Pharmacy has 21 laboratories and a drug information center. Students gain knowledge and skills through internships at industries.

Clinical training for students of the College of Physiotherapy, Department of Management, Sumandeep Nursing College, and Department of Audiology & Speech-Language Pathology is provided at Dhiraj Hospital.

All institutes have skill labs, and the Labdhi Simulation Centre is recognized by the American Heart Association for conducting Certified BLS courses.

An Ayurvedic Medical College and Hospital and Homoeopathic Medical college and Hospital is attached to the Institution, with one-acre herbal garden within the campus, and all the facilities as stipulated by regulatory bodies for providing teaching and learning opportunities related to AYUSH.

Sumandeep Ayurved Medical College & Hospital provides high quality patient Care with 100 bedded hospital and has fully developed departments with all equipments.

Sumandeep Homoeopathic Medical College & Hospital is 25 bedded and has facilities of OPD, IPD, specialty services, laboratory services and dispensary.

The College of Physiotherapy, Department of Audiology and Speech Language Pathology, Sumandeep Nursing College, Department of

### 4.3 - Library as a Learning Resource

The Learning Resource Centre of the Institution is fully automated using the Koha Version 21.11.06.000 system since 2018. Koha is an open-source Integrated Library System (ILS) that employs a web-based interface and a SQL database backend, preferably MySQL, with cataloguing data stored in MARC and accessible via Z39.

The system encompasses several modules including Acquisition, Catalogue, and Circulation Online Public Access Catalogue (OPAC) Serial Control & E mail alert.

The Acquisition module manages major functions such as suggestions management, master files for currency, vendors, publishers & reports.

The Catalogue module facilitates an authority database of personal

and corporate names, subject headings and series names.

The Circulation module handles membership management, maintenance and status of library items, transactions, Inter-Library Loan (ILL), overdue charges, renewals both online and offline & reminders.

The OPAC is a major attraction of the system, featuring advanced search facilities using author, title, subject headings, keywords, class number, series name, accession number, or a combination of these.

The Serial Control module includes master databases, subscriptions, check-in of individual issues of journals, payments, reminders binding and title history.

Additionally, the system offers an email alert service for circulation-related activities such as issue, return, and due.

In addition, the library subscribes to over 253 national and international journals every year, as well as discipline-specific databases like Up-to-date, for easy and convenient access, IP based access has been activated, for remote access students can register for the username and password.

Online Public Access Catalogue (OPAC) of books, journals and several useful resources available on internet have been identified and links are made available on the library Webpage.

The library is in possession of more than 2500 books related to traditional systems of medicine including Ayurveda. The library has institutional membership of DELNET, through which students can access more than 2200 E-Journals on various subjects including traditional systems of medicine.

The library has also developed an institutional repository using D-space open source software. The repository is accessible globally. Project reports, Thesis, Dissertations, Faculty publications, Faculty Lectures etc. can be easily accessed through the repository.

- The HOI gives comment on the overall report of the individual and then sends it for further review by the Registrar and Vice Chancellor.
- The marks are given on the basis of their performance. The final report of performance of teaching and nonteaching staff members are recorded for the purpose of incentives, promotions and the salary increments.

Generally recurring expenses and the capital expenditure are projected to be within the budgeted recourses of the institution. The Optimum Utilization of Resources is implemented by processes like Institution Budgeting, Budget monitoring by Finance Committee and Centralized purchase system.

A total of 57 newly appointed teaching faculty underwent training in Evidence-Based Practice (EBP) at Sumandeep Vidyapeeth, enhancing the overall competence in evidence-based practices within the institution.

In the academic year 2022-23, capacity-building activities for 170 postgraduate students all constituent institutes were conducted.

JBI Collaborative activities: Sumandeep Vidyapeeth Centre for Evidence-Based Health Care, an affiliated group of JBI, created the JBI gLocal Solution Room on June 6, 2023. In this regard, a national-level webinar on the non-pharmacological management of lifestyle diseases was conducted on the same date. A total of 231 delegates were sensitized regarding the non-pharmacological management of lifestyle diseases during the webinar.

Undergraduate EBES modules were conducted across the constituent colleges of the Institution. The modules provided students with comprehensive training in evidence-based education, enhancing their understanding of research methodologies and critical appraisal skills.

Sumandeep Vidyapeeth plans to develop programs and courses for the Department of Jain Philosophy and Research with focus on integration of Indian Knowledge System.

The Institution plans to offer the program of 'Bachelor in Prosthetics and Orthotics' under the Department of Prosthetics and Orthotics which will be a skill based program, from the academic year 2023-24.

The Institution has initiated the procedures to start two masters programs namely - M.Sc. in Audiology and M.Sc. in Speech Language Pathology under the Department of Audiology and Speech Language Pathology.

The Institution plans to reconstitute the faculty of Allied Health Sciences in lines with the National Commission of Allied and Health Care Professionals.
